- Powerful Blower Motor—Exclusively featuring the AquaVENT MAX™ from Fasco™ is the quietest blower motor in the industry. This new blower is a lower profile than previous versions and features a more robust electrical connection.
 - 8.5 Foot (2.6m) Power Cord—Included (120 VAC).
- Horizontal and Vertical Venting—Designed for installations where atmospheric units cannot be used. Exhaust gases are vented under positive pressure directly out of the building through the roof or the wall with PVC, ABS or CPVC (Maximum equivalent vent length on reverse side).
- Ultra Low NOx Burner with Primary and Secondary Air Distribution Devices—Ensures proper air to gas ratio for reduction of NOx generated by the combustion process.
- Defender Combustion Chamber—Incorporates the Advanced ScreenLok® Technology Flame Arrestor and large split-door design to prevent ignition of flammable vapors outside the water heater
- Flammable Vapor Sensor and Resettable Thermal Switch—Coordinates with control to prevent burner operation if flammable vapors are detected. The sensor will also prevent operation if there is ongoing flammable vapors burning inside the combustion chamber (excluding URG2PV75H6N).
- Maintenance-Free—No regular cleaning of air inlet openings or flame arrestor is required under normal conditions.
- Sight Window—Offers a view into the combustion chamber to observe the operation of the pilot and burner.
- Bradford White ICON System®—Intelligent gas control with spark to pilot ignition system eliminates the constant burning pilot. This results in savings of pilot gas during standby periods (120 VAC)
 - Enhanced Performance—Proprietary algorithms provide enhanced First Hour Rating and tighter temperature differential.
 - Advanced Temperature Control System—Microprocessor constantly monitors and controls burner operation to maintain consistent and accurate water temperature levels.
 - Intelligent Diagnostics—An exclusive green LED light prompts the installer during start-up and provides ten different diagnostic codes to assist in troubleshooting.
 - Pilot On Indication—Flashing green LED provides positive indication that pilot is on.

 provides isolation between electric temperature sensor and surrounding water. No need to drain
 the tank when removing gas valve.




